The Goerdeler Kolleg for Good Governance provides professional training in the field of good governance to a new generation of executives from Armenia, Azerbaijan, Belarus, Georgia, Moldova, Russia, Turkey, and Ukraine. In doing so, it aims to foster responsible action in the public sector (public administration and non-profit organizations) as well as in business. The Kolleg is named after the lawyer, civil servant and member of the German resistance Carl Friedrich Goerdeler (1884–1945).

### The Kolleg will enable you to

- :: take active part in seminars, discussions and workshops to extend your professional knowledge and skills
- :: build up your network of contacts in Germany, the EU, and all participating countries, and
- :: make a contribution to the development of good governance in public administration, business, and civil society.

### The year-long program consists of the following units:

- :: a three-week seminar (August 30–September 20, 2014)
- :: a project phase in your home country in which you implement your own plans for a project (October 2014–August 2015)
- :: a mid-year seminar (four days in March 2015)
- :: a concluding seminar (three days in August / September 2015)

The focal points of the Kolleg are:

### Acting responsibly:

Participants will receive additional training and certification in the areas of administration modernization and good governance.

### Gaining insight behind the scenes:

Participants will learn how good governance is practiced in administration, business, and civil society by means of practical examples in Germany and the EU. They will receive exclusive glimpses into political life and have an opportunity to make new contacts and extend their networks.

### Shaping sustainable plans:

Participants develop their own idea for a project with reference to their home institution, receive training as project managers, and initiate their projects in the course of their year at the Kolleg.

The seminars will take place in Berlin, Warsaw, and Brussels.

The following is required of all applicants:

- :: citizenship of one of the following countries: Armenia, Azerbaijan, Belarus, Georgia, Moldova, Russia, Turkey, or Ukraine
- :: residency in one of these countries
- :: a university degree, with proof of outstanding academic performance
- :: several years of professional experience in relevant areas (with responsibilities in personnel or budget matters)
- :: the support of your employer
- :: a specific idea for a project and an interest in good governance and policy
- :: a strong sense of social responsibility and commitment in addition to strong leadership
- :: excellent German and good English language skills

The working language is German.

The Robert Bosch Stiftung will cover travel expenses, costs of accommodation, seminars, and (if needed) a German language course, as well as provide an allowance of 400 euros.
